- Two sets of construction plans if the size of the paper is over 11" x 17".
- Entrance approval for construction on a vacant lot.
- A copy of the deed may be required if the property has been recently purchased.
- Ontario Professional Engineered plans for applicable construction.
- If the plans are designed by the home owner then the following is required on each page of the plans: "I have reviewed and take responsibility for the design activities in these plans and this document contains # of pages" – Print name, date and sign.
- A completed Schedule 1 (attached) if plans are designed by the property owner or a designer. Only property owners, engineers, and architects are exempt from Ministry of Municipal Affairs and Housing Registration requirements.

Approvals from agencies that are required at the time of submission

- Cataraqui Region Conservation Authority approval (if construction is within 15 metres of a flood plain, 50 metres of a water course, a Locally Significant Wetland, an Area of Natural and Scientific Interest, or within 120 metres of a Provincially Significant Wetland.
- Leeds, Grenville and Lanark District Health Unit, if new construction, an addition, or an increase in the number of bedrooms or plumbing fixtures.
- St. Lawrence Parks Commission approval if the construction is within 30 metres of the north side of the 1000 Islands Parkway or with 45 metres of the south side of the 1000 Islands Parkway.
