### **Fire Services**

Fire Services

- Fire Services responded to 4 Incidents. 1 remote alarm, 1 public hazard, 1 fire (structure), and 1 investigation.
- Fire Fighters in Training (FFIT) Participants learned about wildland fires, equipment usage, and water systems in various municipalities, including the village of Lansdowne. They discussed the importance of water for firefighting.
- A food drive has been scheduled for Saturday, March 9, 2024, at several grocery stores in Leeds and Gananoque and throughout the United Counties of Leeds & Grenville. All food collected from this drive will be distributed among food banks in the United Counties to assist those in need.
- The Fire Chief attended the quarterly meeting of the Chief Officers of Leeds and Grenville. During the meeting, participants discussed Radio Communications, EMS, MTO highway response, and the appointment of a County Coordinator and Alternates. The role of the County Fire Coordinator is to arrange the Mutual Aid responses and backups for the United Counties in case of a major incident. Chief Bowman from the Augusta Fire Service is currently serving as the County Coordinator, with Chief Moore from Edwardsburgh Cardinal and Deputy Chief Paul from Brockville as the alternates.

Regional Training Center

- Student eligibility letters were submitted to Academic Standard & Evaluation for the upcoming NFPA 1001 Firefighter I Recruit exam scheduled for April 14, 2024.
- An internal job posting for a temporary part-time administrative assistant for the Regional Training Center was sent to all members. The closing date for applications is March 11, 2024.
- The NFPA 1521 Incident Safety Officer course was completed on March 3, 2024.
- The second weekend of the NFPA 1001 Firefighter I Recruit Class is scheduled for March 8-10, 2024.

Fire Prevention

- Investigation of a fire in an abandoned building has been completed.
- Inspection of a commercial property was completed.
- A compliance order was issued to a residential property due to an immediate threat to life.
