- Special Event Permit application reviews are underway for the following events:

Fire Services

- Fire Services responded to 8 incidents. 3 Fires(vehicle, trash, hydro lines), 2 medicals, 1 motor vehicle accident, 2 requests for public service.
- Eight Firefighter In Training Group (FFIT) members attended the RTC to learn about the training center and the different courses available. This pilot program is scheduled to run for one more week.

Regional Training Center

- The second and final weekend of NFPA 1031 Fire Inspector training is scheduled for March 23-24.
- The NFPA 1001 Firefighter I group will be at the Training Center from March 22-24 for their second-last weekend of certification training. Academic Standard and Evaluation have approved the list of eligible candidates for the April 14 testing date.
- The RTC 2024 Course Calendar will now offer three additional Ontario Fire College courses: Commercial Cooking, Fire Instructor I, and Fire Officer I. We are currently awaiting confirmation to open registration to students.

Fire Prevention

- A follow-up inspection was completed at a local business.
- A visit to Thousand Islands Elementary School for a Public Education session is planned for April.
- An inspection visit was conducted on a multi-unit commercial/residential property with Building and By-law staff in attendance.
- An inspection was completed on Hill Island for a temporary water supply on a construction project.

- March 26th , 2024, 6 p.m.
 - 507, 1000 Islands Parkway- The application proposes to consolidate the existing zoning, permit the continuation of rural industrial and marine manufacturing uses, open storage, and one new storage building. It is proposed to change the zoning of the subject lands from Shoreline Residential (RS) Zone, Shoreline Residential Special Exception 40 (RS-40) Zone, Tourist Commercial (CT) Zone, Tourist Commercial Special Exceptions 9 and 22 (CT-9) and (CT[1]22) Zones, Open Space (OS) Zone and Provincially Significant Wetland (PSW) Zone to Rural Industrial Special Exception 18 (MR-18) Zone.





Planning & Development cont'd

- Public Meetings
- April 8th, 2024, 6 p.m.- Two public meetings are scheduled prior to the Council meeting:
 - <u>2134 Blue Mountain Road</u>- to amend the existing site specific Rural Special Exception 49 (RU-49) Zone to increase the maximum permitted setback from Blue Mountain Road for any structure on the property from 70 metres to 110 metres, to include provisions to address recommendations contained in the Environmental Impact Study submitted in support of the application, and to permit the use of a temporary accessory structure as a site office prior to receiving a Subject Property
 - 474 Park Hill Lane- s to change the zoning of the subject lands from Island Residential 'RI' zone to an Island Residential Special Exception 'RI-X' zone, to facilitate the conversion of an existing detached garage to an oversized sleeping cabin.
