- The Special Event Permit for the Black Creek Rodeo, scheduled for May 24-25 in Lansdowne, is close to completion.
- The Special Event Permit for the Kingston Ottawa Paddling Race, set for August 10 in Seeley's Bay, is still pending as we await site-specific details.
- From April 22 to April 28, the Pitch-In Week event saw the participation of Sweets Corners Elementary School, TLTI staff, council, and the community demonstrate their environmental stewardship. Pitch-In activities will continue on April 27, as Seeley's Bay Area Residents Association hosts an event full of family activities, while the Rockport Development Group is organizing their event now, with the forecast of sunny weather. Fire Services

Fire Services

- Fire Services responded to 6 incidents: 1 medical call, 1 mutual aid response to Gananoque for a structure fire, 1 activated fire alarm, 1 open-air burn complaint, 1 possible gas leak, and 1 vehicle fire.
- The Canadian government has made an announcement regarding the tax credits for volunteer firefighters and rescue volunteers. To help with recruitment and retention issues, the government has decided to double the credit from \$3000 to \$6000 for the 2024 tax year and the subsequent years. This is a great initiative that will encourage more people to volunteer for firefighting and rescue operations.
- Capital purchase of various sizes of hose was received for front-line apparatus and new pumper/tanker arriving in June 2024. The capital purchase of batterypowered hydraulic cutters and spreaders for auto extrication was received for Fire Station 3.
- LTIFD Station 1, Front of Younge, and Town of Gananoque firefighters attended John Campbell's Towing for auto extrication practice on Saturday, April 20.

Training Center

- During the quarterly meeting with the Ontario Fire College, upcoming changes to the new Learning Management System (LMS) and student records were discussed.
- Internal FF2 practical testing was completed on Sunday, April 21.
- Offsite delivery for Augusta Fire was held on April 20 and 21, at the Augusta Fire Station and at John Campbell's Towing for Auto Extrication practical day. We want to express our thanks to John Campbell and his staff for their continuous support in providing Fire Services with the opportunity to train and improve their skills in auto extrication.
