Fire Administration

- Fire services responded to 5 calls for service: 2 fires (1 car, 1 unknown island fire), 1 medical assistance call, 1 fire alarm and 1 public assistance call.
- The washer/extractors arrived as well as the remainder of Personal Protective Equipment. Funding for this equipment was made possible by the Provincial Fire Protection Grant to assist with cancer prevention. The funding allows each station to wash firefighter turnout gear in-house. Leeds Fire applied for this grant in 2024 and were allotted just over \$32,000 to be spent on equipment or programming to help with the prevention of cancer.

Public Meetings

- Four public meetings have been scheduled for 6 p.m. on Monday, May 5th, prior to the Council meeting.
 - 911 Country Lane- Rezoning to satisfy a condition of consent to recognize reduced lot area and frontage for the retained lands.
 - 61 Shipman's Lane- Rezoning of the water lot to a Tourist Commercial Exception
 Zone to add a stationary dock
 - 91 Shipman's Lane- Rezoning to allow the expansion of an existing detached garage and to include a sleeping cabin as a permitted use.
 - 934 Burma Lane- Rezoning to satisfy a condition of consent approval for a lot addition to rezone the area of the lot addition to Tourist Commercial and allow the construction of a septic system to support the existing tourist lodging establishment at 931 Burma Lane.
