### **The Proposed Installation**

Kingston Online Services has proposed a new free standing 46-metre-tall self support style communication facility. The proposal supports enhanced wireless voice & data coverage and capacity for the areas surrounding Centennial Road and Blue Mountain Road.

The proposed installation provides an opportunity to accommodate colocation with other licensed carriers, thus limiting the number of new tower structures required in the area. It will assist in minimizing tower proliferation in the area.
